Catch-up Premium Statement 2019-20

<u>Overview</u>

Year 7 Catch up funding is an initiative introduced by the Government to ensure that

students that have underperformed at Key Stage 2 have the ability to have extra support in which to make the progress that should have been made in primary school. Previously, the Year 7 Literacy and Numeracy Catch-up premium provided schools with an additional £500

for each Year 7 student who did not achieve a scaled score of at least 100 in reading and/or maths at the end of Key Stage 2. The figures were calculated using Key Stage 2 provisional

data and the autumn school census data. The funding now takes into account the size of the

new Year 7 cohort.

At The Sutton Academy the catch up premium funding is clearly identifiable within the

academy budget and the impact of intervention is monitored. The academy is accountable for how it has used the additional funding to support the achievement of eligible pupils and

the Principal reports to the governing body and parents on how effective the interventions

have been in achieving its aims.

Strategies

Strategies to meet the needs of pupils eligible for catch up premium at The Sutton Academy are informed by academic research. The academy assesses the individual needs of eligible

pupils, and spends the funding allocation on targeted support through:

Literacy

Reading books purchased and given out to all students with reading score of below

100.

Targeted Ready to Learn literacy groups to raise reading ages.

• Lexia on line intervention programme.

 Extraction groups for an intense 6 week intervention programme Literacy- Vernon and Salford Tests are carried out three times across the year and show impact

through reading and spelling ages.

• Ready to learn intervention extraction groups in English.

KS5 paired reading programme.



- Extraction groups for an intense 6 week intervention programme Numeracy.
- Ready to learn intervention extraction groups in mathematics.
- Numeracy Ninjas.
- Numeracy breakfast club with additional staffing to support students.
- Additional afterschool Catch-up sessions in English and mathematics

Strategies to meet the needs of pupils eligible for catch up premium at The Sutton Academy in the academic year 2019-20 will include those listed above. In addition to these the following interventions will be targeted to pupils on the basis of their needs:

- Adapted Key Stage 3 Curriculum to ensure that pupils consolidate crucial Key
 Stage 2 assessment objectives and provides appropriate stretch and challenge
- Designated library and reading club at lunchtime for catch up premium pupils

<u>Impact</u>

The impact of the intervention has been measured through assessment of pupils against Key Stage 2 levels, below are the proportions of those eligible for the catch-up premium who achieved a good Level 4 in mathematics or reading by the end of Year 7.

Reading Age 72% of students with Catch up Funding for Literacy were on the Lexia Programme in Y7, they were identified as their reading ages were more than 2 years below their chronological age when they started at the academy in Y7.	43.6% students had a reading age that was in line with or above their chronological age at the end of Y7 18% students had a reading age that was within 2 years below their chronological age at the end of Y7 38% students had a reading age that was more than 2 years below their chronological age at the end of Y7 Therefore 56% of the cohort is still receiving intervention either via small group literacy interventions in the SDC with L3 LSAs, or they are on the Lexia Programme still (albeit moving up levels).
