



Meeting the Duty to Participate	School sixth form, sixth form college, college of FE, higher education, other post 16 education, custodial institutions/juvenile offenders, employed with training, apprenticeships, traineeships, study programmes, other work based learning
Working Towards Participation	NEET with a start date agreed, re-engagement activities
Temporary Break from Learning	Teenage parent, ill health, pregnancy
Not Meeting the Duty to Participate	Employed without training incl part time and temporary, self employed, voluntary work, not settled in the labour market (most NEET), no known address or moved away from LA area, destination not known
