

# Student ICT Acceptable Use Agreement

## Academy Policy

ICT has become integral to the lives of children and students, both within the academy and outside of the academy. These technologies are powerful tools, which open up new opportunities for everyone. These technologies can stimulate discussion, promote creativity and stimulate awareness of context to promote effective learning. Students should have an entitlement to safe internet access at all times.

## This Acceptable Use Agreement is intended to ensure:

- That students will be responsible users and stay safe while using the internet and other ICT for educational, personal and recreational use.
- That the academy systems and users are protected from accidental or deliberate misuse that could put the security of the systems and will have good access to ICT to enhance their learning and will, in return, expect the students to agree to be responsible users.

## Rules

- Do not damage or interfere with the academy equipment
- Do not waste resources
- Do not try to fix problems yourself
- Do not tell anyone your password or let them log in as you
- Do not log in as anyone else
- Do not try to bypass the academy security settings
- Do not obtain or share images or videos of other students or staff without permission from the individuals involved
- Do not send any message that could be seen as rude, offensive or abusive
- Do not access or send any images or videos that could be considered obscene or offensive

## Monitoring and sanctions

What you do on the academy computers is monitored and recorded by staff. This includes:

- Viewing your screen remotely
- Reading emails received and sent
- Logging internet sites accessed
- Viewing files stored on the network

## Reporting issues

If you have any concerns about it, you must speak to a member of staff.

## Acceptable Use Policy Agreement

I understand that I must use the academy systems in a responsible way, to ensure that there is no risk to my safety or to the safety and security of the systems and other users.

**For my own personal safety:**

- I understand that the academy will monitor my use of the systems, devices and digital communications.
- I will keep my username and password safe and secure – I will not share it, nor will I try to use any other person's username and password. I understand that I should not write down or store a password where it is possible that someone may steal it.
- I will be aware of "stranger danger", when I am communicating on-line.
- I will not disclose or share personal information about myself or others when on-line (this could include names, addresses, email addresses, telephone numbers, age, gender, educational details, financial details etc )
- If I arrange to meet people off-line that I have communicated with on-line, I will do so in a public place and take an adult with me.
- I will immediately report any unpleasant or inappropriate material or messages or anything that makes me feel uncomfortable when I see it on-line.

**I understand that everyone has equal rights to use technology as a resource and:**

- I understand that the academy systems and devices are primarily intended for educational use and that I will not use them for personal or recreational use unless I have permission.
- I will not try (unless I have permission) to make large downloads or uploads that might take up internet capacity and prevent other users from being able to carry out their work.
- I will not use the academy systems or devices for on-line gaming, on-line gambling, internet shopping, file sharing, or video broadcasting (eg YouTube), unless I have permission of a member of staff to do so.

**I will act as I expect others to act toward me:**

- I will respect others' work and property and will not access, copy, remove or otherwise alter any other user's files, without the owner's knowledge and permission.
- I will be polite and responsible when I communicate with others, I will not use strong, aggressive or inappropriate language and I appreciate that others may have different opinions.
- I will not take or distribute images of anyone without their permission.

**I recognise that the academy has a responsibility to maintain the security and integrity of the technology it offers me and to ensure the smooth running of the academy:**

- I will only use my own personal devices (mobile phones / USB devices etc) in the academy if I have permission. I understand that, if I do use my own devices in the academy, I will follow the rules set out in this agreement, in the same way as if I was using the academy equipment.
- I understand the risks and will not try to upload, download or access any materials which are illegal or inappropriate or may cause harm or distress to others, nor will I try to use any

programmes or software that might allow me to bypass the filtering / security systems in place to prevent access to such materials.

- I will immediately report any damage or faults involving equipment or software, however this may have happened.
- I will not open any hyperlinks in emails or any attachments to emails, unless I know and trust the person / organisation who sent the email, or if I have any concerns about the validity of the email (due to the risk of the attachment containing viruses or other harmful programmes)
- I will not install or attempt to install or store programmes of any type on any academy device, nor will I try to alter computer settings.
- I will only use social media sites with permission and at the times that are allowed.

**When using the internet for research or recreation, I recognise that:**

- I should ensure that I have permission to use the original work of others in my own work
- Where work is protected by copyright, I will not try to download copies (including music and videos)
- When I am using the internet to find information, I should take care to check that the information that I access is accurate, as I understand that the work of others may not be truthful and may be a deliberate attempt to mislead me.

**I understand that I am responsible for my actions, both in and out of the academy:**

- I understand that the academy also has the right to take action against me if I am involved in incidents of inappropriate behaviour, that are covered in this agreement, when I am out of the academy and where they involve my membership of the academy community (examples would be cyber-bullying, use of images or personal information).
- I understand that if I fail to comply with this Acceptable Use Policy Agreement, I will be subject to disciplinary action. This may include loss of access to the academy network / internet, detentions, suspensions, contact with parents and in the event of illegal activities involvement of the police.

**Student Acceptable Use Agreement**

I understand and agree to the rules included in the Acceptable Use Agreement. If you do not sign this agreement, access will not be granted to the academy systems. I have read and understand the above and agree to follow these guidelines when:

- I use the academy systems and devices (both in and out of the academy)
- I use my own devices in the academy (when allowed) e.g. mobile phones, gaming devices USB devices, cameras etc.
- I use my own equipment out of the academy in a way that is related to me being a member of this academy eg. communicating with other members of the academy, accessing the academy email, VLE, website etc.
